REQUIRED DOCUMENTATION FOR SCREENING

1. Homeless Status Verification: Referral letter from shelter/service provider <u>or</u> current eviction notice from your own rental.

Please bring the following items, if available:

-Picture ID for all adults in the household (18 and over).

 -Social Security Cards for all household members <u>or</u> official letter from the Social Security Administration documenting that a replacement card has been requested.
-Official Identification for all children in the household: birth certificate, medical coupon, vaccination record, school id, etc.

-Proof of Crisis which caused the eviction (the reason you did not pay your rent): Police report, medical bills showing payment, increase utility bill showing payment, loss of job/unemployment claim.

-Copy of Lease/Rental Agreement: Copy of Lease/Rental Agreement listing

Washington Residential Landlord/Tenant Act, RCW 59.18

Tenants must be made aware of the Washington Residential landlord-Tenant Act, RCW 59.18, and be informed on how to use this law when problems arise. Copies of the law are available from the Tenant Union of Washington State at 206.723.0500, local branches of Columbia Legal Services, and on the websites for the Office of the Attorney General (<u>www.atg.wa.gov</u>) and NW Justice Project (<u>www.nwjustice.org</u>). The Tenant Union website (<u>www.tenantsunion.org</u>) answers tenant's questions. The Attorney General's website (<u>www.atg.wa.gov</u>) is a resource for both landlords and tenants.
